### § 1 Scope

### § 2 Conclusion of contract

A user license to Polyglobe is automatically renewed for 12 months at the going fee unless it is cancelled up to 4 weeks before the end of the previous license period. Our cancellation confirmation serves as receipt of the termination of the user license.

### § 3 Use/Delivery

The online service is available at [www.polyglobe.net](http://www.polyglobe.net) and can be accessed from your personal user license.

The availability of [www.polyglobe.net](http://www.polyglobe.net) is subject to the restrictions that typically apply to internet offers, e.g. temporary unavailability due to maintenance or disruption due to force majeure. License fees will not be refunded. In the case of late payments, the operator reserves the right to cease or bar delivery following a previous warning. Place of jurisdiction is Bad Homburg, Germany.

### § 4 Right of use

Polyglobe and its data are limited to the internal authorised use of the individual subscriber and are protected by copyright. Kunststoff Information Verlagsgesellschaft mbH reserves all rights to its publication and content.

Authorisation to use [www.polyglobe.net](http://www.polyglobe.net) is restricted to subscribers of Polyglobe – in the case of legal persons – their employees with a valid subscription including user licenses.
